

- b) That the said student has been admitted on the understanding that his first year is probationary and that he may be required to leave the school at the end of the first term or first year, depending on the level of Retardation or on Medical Grounds if the Headmaster is of the opinion that his capability and attainment do not reach the standard specified as requisite for admission, giving a notice of 2 months to the maximum.
- c) That the Headmaster can, at any time, in the interest of the school, have the student removed if in the Headmaster's sole discretion the student or his parent/guardian has failed to accept the discipline of the school and his continued presence is detrimental to the interest of the other students.
- d) That NO Contributions/Donations/Deposits, partial or full, will be refunded if the said student is required to leave the School during the term time for any reasons.
- e) Our Institute takes all precautionary measures to ensure safety of its students at all given time and circumstances, but due to the extent of retardation/problem on a case to case basis of the individual, the institute is not liable for any damage/charge of anaphylactic reaction of a drug on account of injuries, including animal bites fatal or otherwise, illness or accident, resulting in any sort of injury, disability or death during the stay of the child in the School, Hostel or on a Tour, Camp or Trek, etc. which may be sustained by the student, at any time during his/her stay in School, while taking part in studies, sports and extra curricular or any other form of activities of the School, within or outside the School premises. All expenses that may be incurred in the treatment of such injuries, will be borne by the parent/guardian as provided in the rules of Miracles Home and Research Trust, Kolkata, India.
- f) And that if there is any dispute as to the effect or meaning of these agreement or in any way touching or arising out of these agreement, the same shall be referred to the sole arbitration of the Board of Governors, Miracles Home and Research Trust, Kolkata, India, whose decision shall be final.
- g) The School provides a resident doctor on campus. The school however does not take any responsibility for Anaphylactic reaction of a drug which child sustains in case of treatment administered by the school Resident Medical Officer/any referral hospital out side the school Campus, unless the school has been informed of such allergy by the parents in the medical form supplied by the school.
- h) The Parent/Guardian hereby agrees to indemnify the School/Institute from all risks of any nature whatsoever arising without limitations any duty of care owned under this agreement for any loss, damage, accident, injury or death incur by my ward. I further affirm that if any injury, damage, accident including death by any reason caused to my ward during his stay inside the hostel of the said institution or outside or any of the staff, I hold the said Institution/Hostel not liable and indemnity and hold harmless the said Institution its Agents, Advisors, Volunteers, Board of Governors, Associates, Directors and Employees from and against any and all liabilities claims, suits or actions, court damages and expenses which may be brought or made against the said Institution/Hostel/School on account of any injury, damage, accident and/or death caused to any said ward.
- i) The Parent/Guardian hereby agrees to indemnify the School/Institute for any loss caused to the school or its property or to its people by the ward, as determined by the Headmaster.
- j) The Parent/Guardian agrees to settle the dues and outstanding bills, if any at the end of the academic years or at the time of the ward leaving the School and it is further agreed that the School has the right of lien over the testimonials and other certificates till the dues/outstanding bills by the School.

k) The Parent/Guardian has read the Prospectus of the School/Institute and other related documents and confirms to that the rules, instructions, covenants contained therein are fully understood by the parent and the parent so undertakes to abide by the provisions so set forth
